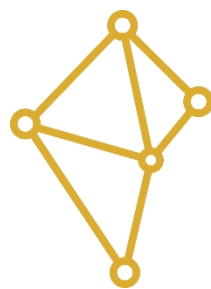

EQUITY SCHOLARSHIP 2020

BACKGROUND

The Equity Scholarships are awarded to students who would otherwise not have the opportunity to receive the type of specialist education provided by Dara School. Scholarships may be awarded for a duration of between one and six years of primary or secondary schooling. The value of the scholarship may cover all or part of the school fees and associated school fees for any given year. The award of each scholarship is reviewed annually.

PURPOSE

The purpose of the Equity Scholarship Fund is the provision of a 12-month Scholarship offered every year to a student who seeks to attend or currently attends Dara School. The Scholarship is to provide the recipient with a specialised education as a foundation towards a future educational pathway.

PREREQUISITIES

- The student must be an Australian Citizen or a Permanent resident of Australia.
- The applicant must be eligible for a Health Care Card.
- The applicant must provide evidence of their financial position.

APPLICATION PROCESS

1. Complete the application form and return to Dara School by the 1st of November each year.
2. Provide scanned, relevant documentation only.
3. Potential candidates are selected on the basis of their written application, the interview process, financial considerations and other relevant information deemed necessary by the Scholarship committee.
4. After consideration of applications, short listed candidates are interviewed by the Principal and a member of the Scholarship Committee.
5. Selection criteria will include:
 - a. which candidate is most likely benefit from the Scholarship; and
 - b. which candidate would most likely be precluded from being able to attend Dara School for financial reasons.
6. The Principal's Equity Scholarship will be award to the candidate who would receive the greatest benefit.
7. The successful applicant will be advised in writing and will receive the required documentation from the Principal.
8. The successful applicant will need to complete the necessary documentation within the specified time, in order to be able to access the Scholarship. Failing this, the Scholarship will be awarded to the next applicant.

NOTE: The Dara School Scholarship Fund is not required to award the Scholarship if it is deemed that no applicants meet the criteria.

The Dara School Principal is authorised to rescind the Scholarship if interaction with the Dara School community or behaviour are deemed as inappropriate or poor. Failure to meet payments within payment terms of the excluded items above will result in a review of the Scholarship offer and its potential withdrawal. The terms and conditions of enrolment for Dara School will apply to the Scholarship.
